# iLive, iSave and iWin Savings Incentive Promotion

## Terms and Conditions

- a) Entrants must be Eighteen (18) years or older and must be the primary account holder on an active Jamaican dollar savings or deposit account at **The Victoria Mutual Building Society (VM Building Society)**;
- b) All eligible account holders with a **balance of J\$100,000** or over at the end of the promotional period are automatically entered for the grand prize draw; each entered account must have a minimum balance of **J\$50,000 on the final date** of deposit indicated for each interim draw to be eligible to win one of the monthly cash prizes;
- c) Only Jamaican dollar accounts in the names of individuals will be eligible for entry in the competition. Accounts in the names of companies, churches or other institutions will not be included;
- d) New and existing VM Building Society savings or deposit account holders who have been entered in the promotion, will receive one (1) chance for every **J\$20,000** of new funds added to their savings or deposit account during the period **May 2, 2022 to December 23, 2022**. These entries will remain to the grand draw date.
- e) Existing VM Building Society savings or deposit account holders who have been entered in the promotion will receive an entry for balances of **J\$50,000** or more held in their savings or deposit account prior to **May 2, 2022** as a reward for their membership. These entries will remain for each draw date;
- f) The final date for deposits to Victoria Mutual Building Society savings or deposit accounts to be eligible for each interim and final drawings are indicated in the table below:

- g) Winners will be randomly selected electronically using a Microsoft excel spreadsheet. Winners will be drawn according to the following order;
- **Monthly Prizes:** Two draws will be conducted, one to determine the winners of **\$20,000**, the other to determine the winner of the **\$100,000 prize**. The first three names selected in draw 1 will be names the winners of the **\$20,000 prizes**. The first name drawn in round 2 will be named the winner of **\$100,000 prize**.
  - **Final Draw:** The 3rd winner will be selected first, followed by the 2nd and finally the first winner. Should any winner become ineligible, the prize will fall to the next in line.
- All draws will be supervised by the selected auditors and as required, the Betting Gaming and Lotteries Commission (BGLC).
- h) The promotion will be conducted throughout all VM Building Society locations.
- i) Each draw will take place at approximately 11:00 a.m. on the dates indicated in the table above at the **VM Group Corporate Office, 73 – 75 Half-Way Tree Road, Kingston 10**.
- j) Verification of entries will be completed within three (3) working days of the draw. All winners will be contacted by telephone. Should the call not be answered, a voicemail will be left. Winners will be announced in the media no later than ten (10) working days after the winner has been confirmed. A minimum of five (5) attempts will be made to contact selected winners within five (5) working days of each draw.
- k) Employees and directors of the VM Building Society or its subsidiary companies, or their immediate family members are not eligible to enter the promotion.
- l) Immediate family members include: spouse, children, parents, siblings and in-laws.
